## Thank you, Betty!

### Generous Planned Gift Leads to Goodness in All Directions

O n the afternoon of September 24th, Elizabeth Nefzger, known as "Betty" to most, invited her five living nieces and nephews to visit at her home within The Vista, on campus of St. John's, so they could all enjoy family connection time. Les Olsen came from his home in Vida, Montana, where Betty and her husband, Ray, had lived and farmed for decades. Agnes Heser came from her home in Wolf Point, Montana. Margaret Graef came from her home in Indianapolis, Indiana. Charles Olsen came from his home in Spokane, Washington. Ruth Laramee lives in Billings. All the nieces and nephews looked forward to the family gathering, but only Betty knew of an additional reason for her invitation – a surprise \$20,000 Charitable Gift Annuity to each, contracted with the St. John's Foundation. A \$100,000 gift in sum!

The beauty of these planned gifts is that each was established as a two-lives immediate gift annuity Agreement. What this means is that Betty's generosity will lead to goodness in four specific expressions. First, because the gifts were offered to the St. John's Foundation Endowment, Betty receives a substantial income tax deduction and substantial Montana state tax credit – goodness to her! Second, for all remaining years of her life, Betty will receive monthly fixed payment cash flow from the St. John's Foundation – goodness to her! Third, at conclusion of all required annuity payments to Betty, each niece and nephew will receive monthly fixed payments from the St. John's Foundation – goodness to them! Fourth, after all required annuity payments under the Agreement are completed, remaining funds shall be distributed to the St. John's Foundation Endowment with no probate fees – good for all whom St. John's serves by providing living opportunities within nurturing environments of hope, dignity, and love. Because Betty's planned gift total of \$100,000 will have home within the St. John's Foundation Endowment, investment policies are in place to pursue growth of gift value, combined with 5% annual earnings distribution to fund ministries of St. John's. Betty's gift truly is a gift that will keep on giving, compassionately impacting lives for generations to come.

When asked to share some additional thoughts about planned giving, Betty offered these responses.

#### Why did you decide to offer these substantial gifts to the St. John's Foundation?

"These are not the first gift annuities I have given to St. John's. I made other gifts and found they were good for my heart. St. John's has been very good to me. I have been very happy here and made lots of friends."

What was the response of your nieces and nephews when you presented these gifts? "They were very surprised. They all had tears in their eyes. It was kind of hard to see that because I had tears in my eyes."

Did you and your husband, Ray, ever talk about planned giving? What would he have thought of this gift? "Ray was a generous man who, in addition to ranching and farming, served as a Baptist pastor in two small congregations nearby where we lived. We did not know about this kind of giving. I learned that from St. John's people. Ray and I worked so hard for all our lives on the farm. If he knew now how our money is being used to help others, he would be happy. He would be very happy. I figure, why not put our money to work to help people."
